Minister Services

\$400

One hour consultation meeting with couple

Purpose is to finalize details of service and for minister to get acquainted with the couple so as to put personal touch on things

Additional ministerial time can be scheduled - \$50/hr

Wedding Rehearsal

One hour to run through logistics of the service including placement of wedding party during wedding, special seating of family members, entrance and exit of participants, special elements in service such as readings or music etc.

Typically scheduled afternoon or evening prior to wedding service

Design of Wedding Service

Performance of Wedding Service

Rental of Ceremony Site & Wedding Coordination **\$700**

Use of Sanctuary*, Chapel, Gazebo, Fountain Courtyard, Unity House or Garden

Sound system with sound technician (*Sanctuary only)

On site prep rooms for bridal party

One hour of set up/break down by our custodian**

Wedding Coordinator to assist in rehearsal, wedding set up and wedding ceremony

Wedding Coordinator to assist ushers with seating and handing out programs, if needed

Wedding Coordinator to coordinate deliveries with ceremony vendors and start times of musicians

Wedding Coordinator to assist minister, wedding party, ushers, family and guests as needed

Wedding Coordinator to line up and cue all ceremony participants in processional

Wedding Coordinator to administer all aspects of marriage license (including filing with County Recorder)

*Additional charges will apply for rental of sound system and sound technician for other areas on site

**Additional Custodial assistance can be arranged for \$25/hr

Booking procedure:

Non-refundable deposit of \$200 to hold date (will be applied to total wedding fee)

Complete Wedding Information Form

Return deposit with completed Wedding Reservation Form

Complete Facilities Use Agreement

Complete Parking Liability Form

Review Facilities Usage Requirements and question/clarify/make requests for special conditions

Request copy of wedding ceremony and review wedding ceremony content options

Set time for ceremony

Complete and return detailed Wedding Information Form

Schedule consultation meeting with Minister

Return Wedding Information Form and ceremony content requests before meeting with Minister

Schedule Rehearsal*

Pay balance of wedding fee one month in advance of wedding date

*Rehearsal note - It is important that the entire wedding party attend including ushers as well as any family members whom will be formally seated during the service procession. If you are including a Unity Candle lighting in the ceremony, please bring the set with you to practice logistics.

Restrictions:

No live or amplified music outdoors (acoustic and recorded music at appropriate volume allowed)

Silk flower petals only for flower girl (indoors)

No bubbles indoors

No rice throwing

Beer/Wine/Champagne only

Event must conclude by 9 pm

Altar urn available for central flower arrangement – must be left for church use if wedding is on a Saturday.

Couples provide Unity Candle set – Church will provide table

Six Candle Candelabras available for use - \$25 ea
